**Course Description:**

This course covers accounting theory and practice related to Liability, Equity and Statement of Cash Flows and various other topics and their impact on the financial statements.

**Course Objectives:**

The primary focus of this course is to advance your understanding of corporate financial reporting. We will draw on real business problems, economics, and finance to help you understand what is contained in financial reports, why the information is presented in a particular way, and how to develop and interpret financial reports.

The content of this course includes fundamental financial accounting concepts and methods. The primary objectives of this course are: (1) to gain knowledge of the functions, practices, limitations, and challenges of financial accounting, and (2) to gain a foundation for further learning in accounting and business.

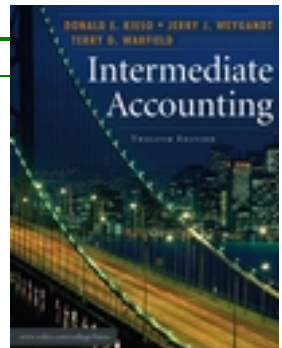

- **Tests**

- **Homework**

Generally, the homework will be graded for completion not accuracy. To receive credit for the on-line homework you need to have at least a 70% correct average for each chapters assignment. When a homework problem is assigned that has a spreadsheet next to it that does not need to be prepared on-line, you should go to the Wiley Plus website and download and use the templates to save yourself some time preparing your homework.

Professional Research Cases can be found at the end of each chapter's homework. These assignments are meant to get you familiar with the FARS Database which is used extensively on the CPA exam. Access to the FARS Database can be found using Wiley Plus. The professional research homework should be completed printed and handed in during class. The homework is due the day it is assigned. 
- **Administration**
