

**SUPPLEMENTAL WAGE
AGREEMENT BY AND BETWEEN
THE BOARD OF TRUSTEES
OF THE UNIVERSITY OF ILLINOIS**

AND

ADMINISTRATIVE COUNCIL FOR LICENSED PRACTICAL NURSES

WHEREAS THE BOARD OF TRUSTEES OF THE UNIVERSITY OF ILLINOIS and ADMINISTRATIVE COUNCIL FOR LICENSED PRACTICAL NURSES entered into a Labor Agreement effective from September 3, 2006 through August 31, 2010 and;

WHEREAS ARTICLE XIV section 2 provided that this agreement was subject to reopening for the sole purpose of negotiating hourly rates of pay for the period commencing August 30, 2008 through September 6, 2009.
