

CHICAGO URBAN LEAGUE

The Chicago Urban League was organized in 1916 primarily to deal with the problems arising from the migration of Blacks from southern rural areas to urban areas in the North. The Urban League assisted the migrating Black population in adjusting to an urban social and economic environment, including one which was particularly hostile and anti-racial. The Chicago Urban League thus became the first permanent social welfare agency in the city of Chicago to handle exclusively Black social and economic issues and problems. Among the first members of the League's Board of Directors were Dr. Horace Bridges, Harry D. Oppenheimer, Judge E.O. Brown, Celia Parker Woolley, Jane Addams, and Willoughby G. Walling.

Within less than four years, the Chicago Urban League succeeded in establishing a working relationship between many Black and White citizens of Chicago; a working liason which attempted to promote harmonious inter-racial relations. During the 1919 race riots in the city of Chicago, the Urban League worked tirelessly to ease racial tensions and to demand equal justice for Blacks.

During the 1920's the idea of forming neighborhood clubs to encourage community planning was first conceived. As residential areas developed in which Blacks resided, the Chicago Urban League created block clubs and community councils. These community organizations set up programs and activities which promote community improvements, better housing conditions, and neighborhood conservation. The "Block Beautiful" contest is only one example of an activity which these community councils sponsor.

Coupled with the above the Chicago Urban League also concentrated on gaining employment for Blacks, especially in the industries of Chicago. This effort was temporarily abated during the depression years of the 1930's as the Chicago Urban League set up soup kitchens and emergency relief projects to aid a large number of Black who were unemployed. The Chicago Urban League also worked with the Works Progress Administration in integrating Blacks into its many sponsored Illinois activities and projects.

During the next two decades, the Chicago Urban League focused attention on obtaining employment opportunities for Blacks and toward gaining entry into various unions and trades. The Illinois State Employment Service began employing Black staff workers and Western Electric increased

its number of Black employees from 30 to over 3,000 in one plant alone. Candy manufacturers like Brach's, Bunte, and Curtiss began hiring Black women for the first time. The printing trades, such as W.F. Hall, R.R. Donnelley, and Cueno, began accepting job applications from Blacks and pharmaceutical houses, like Bauer and Black, and department stores like Carson Pirie Scott & Co. began employing Blacks in executive positions.

Further, the Chicago Urban League supported investigations of alleged discriminatory practices by companies awarded federal government contracts and the League cooperated with other human relation groups to secure fair employment practices and favorable Illinois state legislation. The League also directs part of its employment opportunity towards Black youths by acquainting them with career opportunities and by providing them with vocational guidance. Vocational opportunity campaigns are conducted and career conferences for Black youths are held annually.

For more than 30 years, the Chicago Urban League's office facilities were located in the old Frederick Douglass Center on South Wabash Avenue. This building was deteriorating rapidly and a fire there in 1949 only made the building more unsuitable for use. A building fund-raising campaign was launched in 1949, but numerous problems relating to site location, internal factional disputes and raising adequate building fund monies prolonged the search for and move to a new building. In 1959 the Chicago Urban League moved to the building at 2400 South Michigan Avenue, leasing it from John Sengstacke, publisher of the Chicago Defender.

The Chicago Urban League is part of a national movement, the headquarters of which are in New York City and which has affiliates in 60 cities throughout the United States. Local affiliates of the National Urban League carry out the basic program and objectives of the national organization, but they adopt their own methods and activities to the particular needs of the local community. The local urban league is an autonomous agency with its own administration and independent means of income. Thus, the Chicago Urban League has its own Board of Directors making policy decisions and governing its own activities. The most important committees of the Board of Directors and Finance and Budget, Nominating, Personnel, Public Education, Community Organization and Industrial. The League's operations are delegated to a professionally

trained staff under the direction of the Executive Director. Committees made up of leading citizens working jointly with the League's staff towards developing programs of the League's major departments, namely Administrative, Community Organization, Industrial Relations, Public Education and Vocational Guidance.

Half of the League's annual budget is provided by the Community Fund of Chicago, Inc., while voluntary contributions from individuals, private industry and business and other community organizations make up the other half. Membership in the Chicago Urban League is open to the general public.

Records of the Chicago Urban League were obtained through the Department of History and deposited in the Manuscript Section of the University Library on February 15, 1966 with restrictions.

The Chicago Urban League Records are divided into eight categories. They are Administrative, Community Organization, Financial, Industrial and Vocational Guidance, Human Relations, National Urban League, Housing and Public Relations. The League's subject classification scheme arranged alphabetically thereunder in each of the eight categories was maintained, when catalogued. The researcher should also be aware that the bulk of these records date from 1940; the earlier materials were destroyed by a fire.

The first category contains papers of the Administrative Department, and they consist of correspondence, programs, memoranda, agenda and minutes of meetings, lists, reports (committee, statistical, activity, annual), publications, job specifications, photographs, news releases, invitations, newspaper clippings, and newsletters of the Chicago Urban League. Also, they include annual reports, minutes of meetings, reports, memoranda, and publications of organizations other than the League.

Material in this section contains information on the building fund campaign of 1952; the League's relationship with the Community Fund of Chicago and Community Neighbors; discrimination by the Morris B. Sachs store; the League's Presidents (Dickerson and Pierce) and the Executive Secretaries (Williams, Lane and Berry); the Fund for Adult Education; health and welfare of Chicago Black's population; employment opportunities and housing facilities for Blacks, including Trumbull Park Homes Project; the Negro Press Anniversary Dinner of 1952; its social functions; the selection of a new executive secretary; the activities of the Urban aides a women's auxiliary of the League; and union activities and agreements.

Records of Supplement I are divided into the following categories, each of which corresponds to one of the Chicago Urban League's administrative departments. They are 1) Administrative, 2) Community Organization, 3) Financial, 4) Housing, 5) Industrial and Vocational, 6) Public Relations, and 7) Human Relations Departments. Also included is the category, the National Urban League, a division consisting of material received from the national organization and its affiliated branches.

Records of the Chicago Urban League, Supplement I consist of correspondence, newsletters, sound recordings, statements, studies, proposals, resolutions, charts, directories, agenda and minutes of meetings, announcements, memoranda, bylaws and constitutions, newspaper clippings, press releases, case histories, proceedings of conferences, manuals, photographs, reports (narrative, monthly, statistical, quarterly and annual), financial records, and labor agreements.

The material contains information on negotiations with local office workers unions; the 1952 Negro Press Anniversary dinner; organizing and directing community councils in Chicago's Black neighborhoods; vocational training sessions for Black students in Chicago Public Schools; race riots in Illinois in the 1950's; employment opportunities for Chicago's Black citizens; job discrimination; housing facilities in Chicago Black neighborhoods; financial transactions of the League; Chicago-based human relations and civil rights organizations; and policies and practices of the National Urban League and its affiliates.

The Chicago Urban League Records were unorganized, when received. Subsequent to a review of the League's administrative structure as gleaned from the main body of records received earlier, the records of this supplement were organized to reflect the daily function and administrative set-up of the organization.
