Part II: Timeline of Major Events in the College of Urban Planning and Public Affairs

- 1966 Center for Urban Studies is established (Source: University of Illinois Board of Trustees Reports, 54th Report)
- 1970 College of Urban Sciences is established (Source: University of Illinois Board of Trustees Reports, 55^h Report)
- 1971 Curriculum authorized leading to Masters in Urban Planning and Policy, to start September 1972. Offered by College of Urban Sciences in cooperation with Medical Center, College of Architecture and Art, Jane Addams Graduate School of Social Work, College of Engineering, College of Liberal Arts and Sciences, and College of Business Administration. - 1973 Task force organized to develop Masters in Urban Planning and Policy in College of Urban Sciences. (Source: University of Illinois Board of Trustees Reports, 58^h Report)
- 1976 The College of Architecture and Art and the College of Urban Sciences merge to form the College of Architecture, Arts and Urban Sciences. The new college is organized into three schools:
 - School of Architecture
 - School of Art and Design

- 1977 Transportation Planning in Master of Urban Planning and Policy specialization is established. (Source: University of Illinois Board of Trustees Reports, 59^h Report)
- 1979 Urban Transportation Center is established. The Center reports to the Office of Sponsored Research and has a policy committee composed of the deans of the Graduate College, and the Colleges of Architecture, Art and Urban Sciences; Business Administration; Engineering; and Liberal Arts and Sciences. - 1981 Center for Urban Studies divided into two units:

- 1993 The Bachelors of Arts in Music and music minor in Liberal Arts and Sciences is transferred to Department of Arts in Art and Architecture and Urban Planning (University of Illinois Source: Board of Trustees Reports, 67^h Report)
- 1994 The Urban Transportation Center is transferred from the Office of the Vice Chancellor for Research to the School of Urban Planning and Policy in the College of Architecture, Art and Urban Planning (Source: University of Illinois Board of Trustees Reports, 67^h Report)
- 1994 Board of Trustees approves the establishment of the College of Urban Planning and Public Affairs. The College initially consists of four units:
