Health Insurance

The University of Illinois system has a group policy for international health insurance coverage for students and accompanying faculty going abroad. The policy is with Cultural Insurance Services International (CISI). The Study Abroad Office is the designated enrollment point for UIC.

CISI insurance is available to all registered UIC undergraduate, graduate, and professional students who will be participating in a program of study overseas, including students conducting independent research, fieldwork, and internships. It also applies to accompanying UIC faculty or staff, and faculty or staff traveling abroad on official university business.

For those students who apply to study abroad through the UIC Study Abroad Office, enrollment in CISI is automatic.

For departments or faculty members independently administering a program or supervising an educational activity overseas, the procedure to enroll in CISI is as follows:

1. Contact the Study Abroad Office (kmcphe1@uic.edu) and request a registration/information form. This will be emailed back to you.
2. Once the registration form is completed, both an electronic (send to: kmcphe1@uic.edu) and hard copy need to be returned to the Study Abroad Office. With the hard copy, payment in full can be made by either a single money order for the total for all participants, or multiple money orders. Money orders(s) should be made payable to CISI.
3. Upon receiving the completed information form and payment, the Study Abroad Office will issue the required number of insurance cards and information about the plan coverage. Students conducting independent research, fieldwork, and internships should contact Krystal McPherson at kmcphe1@uic.edu for enrollment forms and plan information.

Premiums are paid three times per year. The **firm deadlines** for registration and payment are:

- ❖ **April 18th** for Summer 2008 term, and for Fall 2008 programs with a start date before **August 15th**
- ❖ **August 1st** for Fall 2008 term or 2008/2009 academic year
- ❖ **November 14th** for the Spring 2009 term

Length of Program	Cost of Insurance
0 – 15 days	\$20.50
16 – 45 days	\$28.50
46 – 75 days	\$67.00
76 – 195 days	\$115.00
196 – 315 days	\$273.00
316 – 397 days	\$321.00

General Schedule of Benefits:

- Medical Expense (Accident/Sickness) \$100,000
- Deductible per Injury/Illness \$-0-
- Accidental Death & Dismemberment \$10,000
- Emergency Medical Repatriation/
- Return of Mortal Remains \$50,000
- Emergency Family Reunion Benefit \$3,000
