Medicine

The UIC College of Medicine (COM) and the School of Public Health (SPH) offer a five-year program of study leading to joint MD/MPH degrees.

Graduates of the joint MD/MPH program are well-poised to keep pace with the increasingly complex and inter-related fields of medicine and public health. Medical students in the combined degree acquire rudimentary epidemiologic and statistical concepts enabling them to understand population-based health phenomena, skills to successfully manage limited health resources, and principles of community and environmental health which bear on the health of the population. More advanced public health courses enable the student to augment his or her medical training with a deeper understanding in one of the following disciplines: epidemiology, health policy and administration, community health sciences or environmental and occupational health sciences.

Admission to the Program

Students are encouraged to apply to the joint degree program at the outset of their training. However, in unusual circumstances, medical students may apply to the joint program during their first year of medical school. Incoming students must apply to and be accepted by both the College of Medicine and the School of Public Health; students who choose the dual-degree program should therefore have higher-level academic talent to accomplish the goals of the combined program. Applicants to the School of Public Health must select one of the School's four divisions: Community Health Sciences, Epidemiology and Biostatistics, Environmental and Occupational Health Sciences or Health Policy and Administration, at the time of application.

Program of Study

The joint MD/MPH degree program is a five year program of study. Students in the program must satisfy requirements of the Masters of Public Health Professional Enhancement Program (PEP), a 34 to 39 semester hour program, and satisfy four years of the required Medical Degree program of study. The student's public health studies will vary depending on the selected division.

Progression Through the Program

Students are encouraged to take advantage of the summers before and after the College of Medicine (M1) year to complete some of the MPH core course requirements. Concurrent public health course work during the M1 through M3 years is discouraged. However, SPH night or computer courses might be allowed at the discretion of the advisors (subject to approval of the COM program governing body or Senior Associate Dean and the SPH Associate Dean for Academic Affairs) for select students who have established excellent academic standing in both the College of Medicine and School of Public Health.

Typically, the fourth year of the five-year program will be dedicated to completing the core requirements and much of the elective course load of the Master of Public Health degree. In the fifth year, students complete all M4 requirements including the medicine sub-internship and the core sub-specialty rotations, the SPH capstone experience, and College of Medicine clinical electives which may be satisfied by approved course work in the SPH.

An alternate route to completing the joint program permits medical students to complete their M1 through M4 years in succession followed by a year of concentrated study in public health. This latter route is discouraged for students who are interested in a highly competitive medical residency program.

Business Administration

The College of Business Administration and the School of Public Health offer a program of study leading to the Master of Business Administration and the Master of Public Health. The joint MBA/MPH program is designed for baccalaureate-prepared students who are seeking health care and business preparation for health care executive positions in government, hospital systems, long-term care, health maintenance organizations, planning/regulatory bodies, and consulting.

Admission to the Program

To enter the program, a person must make separate applications and be admitted to both the Master of Business Administration program and Master of Public Health program. Admission to the Master of Public Health program is through one of the School's four academic divisions. The policies of each program with respect to admission requirements, degree requirements, and other academic requirements are applicable.

Program of Study

Students must complete a minimum of 70 semester hours of appropriate graduate work through a combination of core and elective courses to satisfy the joint degree requirements. Most students will complete the joint degree in two and one-half years on a full-time basis or in three and one-half years on a part-time basis.

Elective hours must raise the total hours for the joint degree to at least 69-70 sh depending on the division:

- MBA Electives (12 sh)

Students must take at least three elective courses (twelve semester hours) from courses offered within at least two departments in the College of Business Administration. Students also have the option to complete a concentration if desired.

- MPH Electives (18-23 sh)

Students must satisfy requirements of one of the public health disciplines offered by the School of Public Health. For some divisions more than the minimum number of credit hours must be completed.

Nursing

The UIC College of Nursing and the School of Public Health offer a program leading to two degrees: the Master of Science (MS) in Nursing with specialization in public health nursing and the Master of Public Health (MPH) with specialization in community health.

The joint-degree program is designed for registered nurses seeking an advanced nursing degree and public health experience to prepare them for high-level administrative, consulting, and leadership positions in the public health field. Nurses who complete the joint-degree program will be well prepared to take leadership positions in a variety of settings and programs that are community-based or population-focused. The joint-degree program helps nurses to integrate clinical knowledge and administrative expertise with public health practice to improve the delivery of health services in a variety of settings.

Nurses take both CON and SPH courses to satisfy the degree requirements of the joint program. A faculty advisor is assigned from each academic department to assist the student. Within CHS, students focus on assessing public health needs and developing community-based programs and interventions. Students are strongly encouraged to take elective courses in the areas of behavioral sciences and health promotion, maternal and child health, gerontology, or public health practice.

Admission to the Program

Nurses interested in this program must be admitted separately to both the School of Public Health (SPH) through the Community Health Sciences Division (CHS) and the College of Nursing (CON) through the Department of Public Health, Mental Health and Administration (PMA).

Program of Study

The following 56-58 credit program is tailored to accommodate full-time students working to complete both degrees in two academic years. - CHS Field Experience

The curriculum for the MPH includes an extensive community-based practicum that each student selects whereas the CON courses have community-based clinical components. The MPH practicum and the Master's Paper represent the capstone/culminating experience in the CHS curriculum. The practicum provides an opportunity for nurses to move from acute care to community-based practice. Students choose a practicum site based on his or her interest, thus the practicum serves as a stepping-stone for moving into the community setting and into leadership roles that involve program development and administration. Students who have been approved for the 3-credit field experience are required to take an additional SPH course of at least 2 credits. Law

The UIC School of Public Health (SPH) and the Chicago-Kent College of Law, Illinois Institute of Technology offer a coordinated program leading to the Juris Doctor (JD) and the Masters in Public Health (MPH).

The goals of this Coordinated Program include (1) providing students with a core understanding of the ways in which law and public health work together, (2) enhancing the educational value of each degree by coordinating respective curricula, and (3) helping develop a well-trained group of professionals capable of addressing issues at the intersection of public health, medicine, and law.

Admission to the Program

To be considered for admission students must take the LSAT, have earned a baccalaureate degree from an accredited institution, and satisfy other application requirements for each institution. Applicants who are accepted into both schools will be considered enrolled in the Coordinated Program. Applicants who are accepted into one school, but not the other, will be given the option of accepting matriculation to that school. Students in the Coordinated Program will have the option of starting at either institution, and will have to comply with that institution's rules for enrollment.

Program of Study

Both programs may be completed in 3 ½ years for full-time law students and 4 ½ years for part-time law students. Students in the program will be assigned faculty advisors chosen from among the attorneys on the faculty of the School of Public Health and from the faculty members engaged in health-related issues at Chicago-Kent. Each student will be assigned one advisor from each school.

Students must complete one year of course work (or the equivalent) at SPH through the Health Policy and Administration Division (HPA) of the school. Students' work at UIC will qualify for twelve hours of elective credit at Chicago-

Kent (approximately one semester's work). During the remaining semesters at Chicago-Kent, the students will be required to meet all other curricular requirements of the law school. Students may begin their study by attending either school first, but cannot take courses at both schools during the same semester without special approval by both schools. Students receiving financial assistance are advised to attend only one school during an academic year.

- Masters of Public Health Coursework

The MPH component will consist of at least 37 to 39 semester hours of course work. This includes the Core Required Courses (19 semester hours) and at least 15 semester hours of electives decided upon in collaboration with the student's faculty advisor.

Students must also complete the School's field practicum experience (at least 300 hours of professional work in the student's field of study) (3-5 semester hours) and satisfy the School's capstone requirement. To satisfy the capstone requirement, students must demonstrate their ability to integrate concepts, theories and skills from the core public health disciplines into analysis of a public health issue, program or policy.

- Law School Coursework

Students must meet all of the law school academic requirements for graduation. In the first year of study, students will take all required courses, including Torts, Contracts, Real Property, Criminal Law, Civil Procedure, Justice and the Law, Legal Research and Legal Writing - in the same sequence as other law students, as well as non-health-related electives. To meet graduation requirements, students must complete a total of 75 credit hours in addition to the 12 credits they receive for the SPH course work upon successful completion of the MPH requirements.

While the student is at one school, he or she will be considered on official leave of absence at the other school. Students will pay the tuition and fees of the school at which they are taking classes. Upon completion of both programs, the student will be awarded both degrees.

Location

The IIT Kent College of Law is located in a new state-of-the-art building on the west end of Chicago's downtown loop. Metropolitan Chicago is the home of seven medical schools; major health organizations (e.g., American Hospital Association, American Medical Association, Joint Commission on Accreditation

of Health Care Organizations); the American Bar Association and large health care companies such as Baxter and Abbott Laboratories. These resources provide a rich environment for study and field placement experiences for students pursuing the coordinated degree.

Veterinary Medicine

The College of Veterinary Medicine at the University of Illinois Urbana-Champaign (UIUC) and the School of Public Health at UIC offer a joint degree program leading to the Doctor of Veterinary Medicine (DVM) and Master of Public Health (MPH) degrees. Joint degree students will be awarded their degrees by the respective campuses upon successful completion of both programs.

Veterinarians have played an historically long and essential role in protecting the public's health as many human diseases have animal vectors and animals frequently serve as sentinels signaling environmental degradation and human disease potential. Naturally occurring outbreaks of SARS, avian flu virus, West Nile virus, monkeypox and tularemia in prairie dogs illustrate the need for highly qualified persons trained in zoonosis and public health epidemiology. Bioterrorist threats further the demand for these specially trained individuals.

Veterinary students in the combined degree will acquire epidemiologic and statistical concepts enabling them to understand population-based health phenomena and principles of community and environmental health which bear on the health of the population. More advanced public health courses in epidemiology will strengthen the student's veterinary training.

Admission to the Program

Students must meet the admissions criteria of, and be accepted into, both the UIC School of Public Health MPH program and the UIUC College of Veterinary Medicine DVM program. DVM students must have earned a baccalaureate degree to qualify for admission to the joint degree program.

Program of Study

The joint DVM/MPH degree program is a five-year program of study. Students in the program must satisfy requirements of the Masters of Public Health Professional Enhancement Program (PEP), a 35 to 39 semester hour program, and satisfy four years of the required Veterinary Medicine Degree program of study.

Progression Through the Program:

Veterinary students will ordinarily complete Years 1 through 3 of their veterinary training at UIUC, while taking some public health courses online and/or completing courses deemed equivalent to required SPH courses within the graduate programs of Veterinary Pathology and Veterinary Biosciences. DVM students will spend a minimum of two semesters (fall and spring) in residence at the UIC School of Public Health following their third year of veterinary training. Students are encouraged to spend a summer in Chicago to complete their field experience and capstone project in a public health related setting. Students will return to UIUC to complete their fourth year clinical rotations.

MD/PhD Training Program

Our society has a need for physicians who are accomplished population-based researchers as well as competent clinicians -- individuals whose skills can bring the powers of epidemiology and biostatistics to bear on the problems of clinical medicine that have both individual and community effects. MD/PhD training in epidemiology and/or biostatistics provides an extended period of study in the etiologic and methodologic approaches of population-based health research in concert with complete medical school education. Application is normally made at the time of application to the College of Medicine; however, applicants will also be considered during their first two years of medical training. Students must apply to the MD/PhD Training Program and to the College of Medicine, and indicate in their application that they are interested in a PhD in epidemiology or biostatistics. Criteria for admission to the Program include academic excellence, prior research experience, potential for independent and creative research, and commitment to a career in academic medicine. Students receive a stipend throughout their years of study.
